### Government Order

- (d) There will be no financial involvement of the Government of Bangladesh in this Program;
- (e) They will leave Bangladesh for Italy on 17 February 2018 or on a nearer date and will leave Italy for Bangladesh on 29 February 2018 or on a nearer date;
- (f) They will not be allowed to stay abroad more than the approved period; and
- (g) They will have to submit a report to the Ministry of Agriculture within 7 (seven) days (as per prescribed format of MoPA) of after return from the visit.

3. This order is issued with the approval of the competent authority.


